PERATURAN PEPERIKSAAN SECARA DALAM TALIAN**

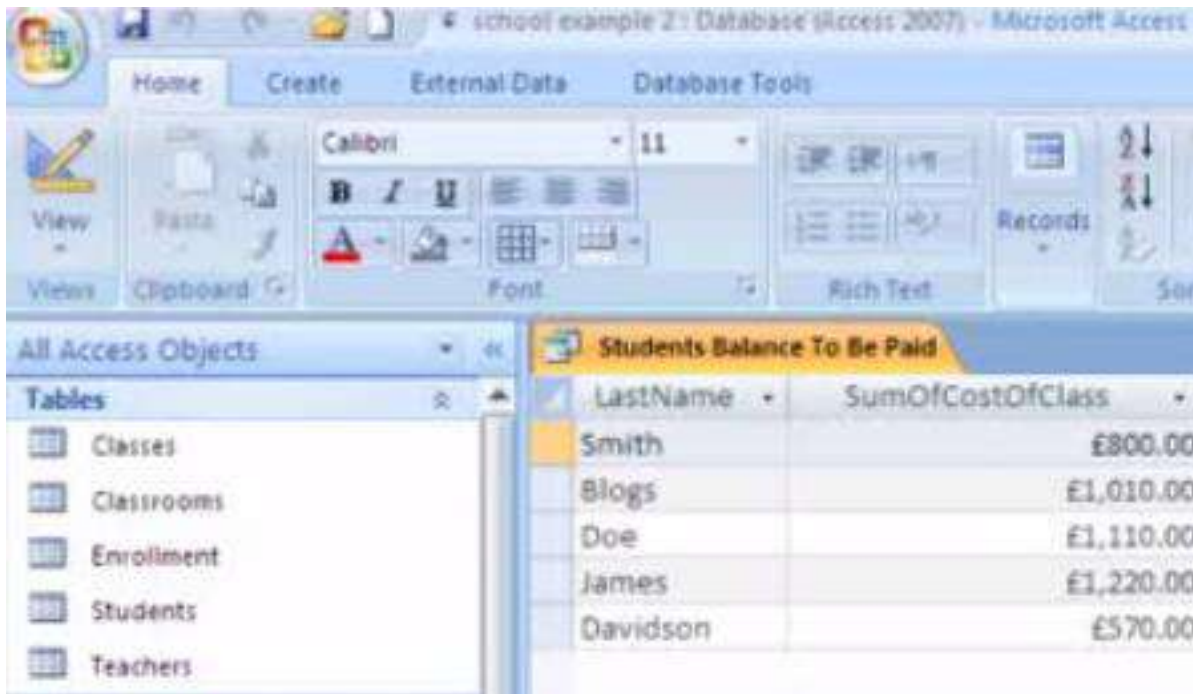
